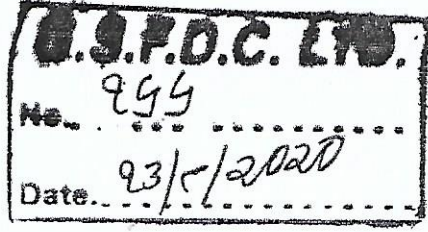

ઉપરોક્ત વિષય અંગેનાં આપનાં સંદર્ભ દર્શિત પત્ર અન્વયે જણાવવાનું કે. નાણા વિભાગે નિગમની " સિનિયર મેનેજર " ની જગ્યાના ભરતી નિયમો નીચે મુજબ મંજૂર કરેલ છે. જે પ્રસિધ્ધ કરી આ વિભાગ તથા નાણાં વિભાગની "અ" શાખાને જાણ કરવા વિનંતિ છે.

In exercise of the powers conferred by Object Clause No. 42 of Memorandum of Association of Gujarat State Forest Development Corporation Ltd (GSFDC Ltd.) and in supersession of all the existing rules made in this behalf, the Board of Directors makes the following rules to provide for regulating recruitment to the post of Senior Manager (Equivalent to Class-I) in the Corporation (Read with the Gujarat Civil Services Classification and Recruitment (General) Rules 1967 amended up to 31.07.2013).

1. These rules may be called the Senior Manager, in the General Senior Manager Services, under the Gujarat State Forest Development Corporation Ltd. of Vadodara Recruitment Rules, 2020

2. Appointment to the post of Senior Manager, in the General Senior Manager Services, under the Gujarat State Forest Development Corporation Ltd. of Vadodara shall be made either :-

(A)(a) by promotion of a person of proved merit and efficiency from amongst the person who :

(i) have worked for not less than 8 years in the cadre of Divisional Manager or Divisional Manager -Marketing, in the General service under the Gujarat State Forest Development Corporation Ltd. of Vadodara, of Forest and Environment Department.

Promotion shall be done on the ground of seniority-cum-merit basis.

Provided that where the appointing authority is satisfied that a person having the experience specified in sub clause (i) above is not available for promotion and that it is necessary in the public interest to fill up a post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period specified in sub clause (i) above with approval of the Government.
