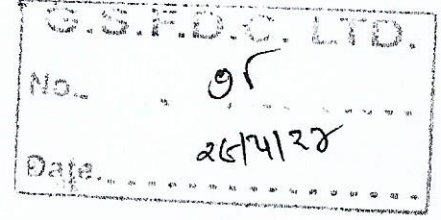

ઉપરોક્ત વિષય અંગેનાં આપનાં સંદર્ભ દર્શિત પત્ર અન્વયે જણાવવાનું કે, નાણા વિભાગે નિગમની " પ્લાન્ટ ઈન્જિનેર " સંવર્ગની જગ્યાના ભરતી નિયમો નીચે મુજબ મંજૂર કરેલ છે:

		In exercise of the powers conferred by Object Clause No. 42 of Memorandum of Association of Gujarat State Forest Development Corporation Ltd (GSFDC Ltd.) and in supersession of all the existing rules made in this behalf, the Board of Directors makes the following rules to provide for regulating recruitment to the post of Plant Engineer in GSFDC LTD. (Read with the Gujarat Civil Services Classification and Recruitment (General) Rules 1967 as amended from time to time).
1		These rules may be called the Plant Engineer -Class-II Equivalent in Gujarat State Forest Development Corporation Limited, Vadodara Recruitment Regulations, 2023.
2		Appointment to the post of Plant Engineer -Class-II Equivalent in Gujarat State Forest Development Corporation Limited, Vadodara shall be made either:-
	(a)	By promotion of a person of proved merit efficiency from amongst the persons who:
	(i)	Have worked for not less than Seven years in the cadre of Dy. Plant Engineer, in the subordinate service of the of Gujarat State Forest Development Corporation Limited, Vadodara.
		Provided that where the appointing authority is satisfied that a person having the experience specified in sub clause (i) above is not available for promotion and that it is necessary in the public interest to fill up a post by promotion, even of a person having experience for a lesser period: it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period specified in sub clause (i) above;
	(ii)	Have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Computer Competency (Training and Examination) Rules, 2006; OR
	(b)	By direct selection/ on the basis of the result of the competitive examination held for the purpose;
3		The appointments by direct selection and by promotion under the sub rule (a) and (b) of Rule 2 shall be made in the ratio of 1:1.
4	(a)	To be eligible for appointment by direct selection to the post mentioned in Rule -2, (b) Candidate shall-
	(i)	be not more than 38 years of age;
		Provided that age limit of candidates belonging to the Scheduled Caste, Scheduled Tribes and Socially and Educationally Backward Class candidates shall be relaxed up to the extent Five years.

		Provided that the upper age limit may be relaxed in favor of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967
		Provided further that nothing contained in sub-Rule (9) of Rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned.
	(ii)	possess:-
		A Bachelor of Engineering(Mechanical) of any of the universities established or incorporated by or under the Central or state Act in India or any other educational institutions recognized as such or declared to be a deemed university under section 3 of the University Grants Commission Act, 1956 or possess an equivalent qualification recognized by the Government ;
	(iii)	Appointment may be made by direct selection in which case the eligible person shall have minimum 3 year experience in a responsible position with sufficient experience in product planning, Production, Maintenance, Material Planning and production cost reduction Techniques in an engineering company. Experience in a wood working Unit will be an added advantage.
	(iv)	Possess adequate knowledge of Gujarati or Hindi, or Both
	(v)	The Candidate appointed by direct selection will require to pass an examination in Hindi or Gujarati or both in accordance with the rules.
	(vi)	Eligible Candidates Shall have to qualify a prescribed competitive entrance examination with minimum prescribed percentage of marks.
	(vii)	The Candidate appointed by direct selection on the basis of result of competitive examination held for the purpose shall during the probation period, be required to pass the qualifying examination for computer knowledge in accordance with the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
	(viii)	The Candidate selected shall have to pass medical examination as per Gujarat government Rules.
5		The Candidate by direct selection shall be on probation for a period of two years.
6		The candidate appointed by direct selection will be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government/GSFDC.
7		Interpretation on a case of doubt If any question arises as to the interpretation of any of these regulations, the question shall be referred to the Secretary to the Government; finance Department for the decision and his decision in the matter shall be final.
