ઉપરોક્ત વિષય અંગેનાં આપનાં સંદર્ભ દર્શિત પત્ર અન્વયે જણાવવાનું કે નાણા વિભાગે નિગમની " સુપરવાઇઝર " સંવર્ગની જગ્યાના ભરતી નિયમો નીચે મુજબ મંજૂર કરેલ છે:

Sr. No.		In exercise of the powers conferred by Object Clause no. 42 of Memorandum of Association of Gujarat State Forest Development Corporation Ltd (GSFDC Ltd.), Vadodara and in supersession of all the existing Regulations made in this behalf, the Board of Directors makes the following rules to provide for regulating recruitment to the post of Supervisor in GSFDC LTD. {Read with the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from time to time.}
1		These Regulations may be called the " Supervisor " in Gujarat State Forest Development Corporation Ltd, Recruitment Regulations, 2023.
2		Appointment to the post of Supervisor in Gujarat State Forest Development Corporation Ltd, shall be made either:-
	(a)	by promotion of a person of proven merit and efficiency from amongst the persons who: have worked for not less than five years in the cadre of Assistant Supervisor/ Van Aushadhi Assistant Supervisor in Gujarat State Forest Development Corporation Ltd., Vadodara; Promotion shall be done on ground of seniority -cum-merit basis.
		OR
	(b)	by direct selection/on the basis of the competitive examination held for the purpose;
3		The appointments by direct and by promotion selection under the sub rule (a) and (b) of Rule 2 shall be made in the ratio 1:5 respectively
4		To be eligible for appointment by direct selection to the post mentioned in Rule-2, a candidate shall-
	(a)	Not be more than 35 years of age. Provided that age limit of candidates belonging to the Scheduled Caste, Scheduled Tribes and Socially and Educationally Backward Class and candidates who are woman, will be relaxed to the extent of five years.

	Provided that the upper age limit may be relaxed in favor of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.
(b)	be a Graduate in any discipline from an University established or incorporated by an Act of the Central or State Legislature in India or any other Educational Institution recognized as such or declared to be deemed as University under Section-3 of the University Grants Commission Act, 1956 or possess an equivalent qualification recognized as such by the Govt.
(c)	Eligible candidates shall have to qualify a prescribed competitive entrance examination with minimum prescribed percentage of marks.
(d)	Qualified candidates shall be called in the order of their merit, to qualify in a prescribed Physical endurance test.
(e)	The candidate appointed by direct selection shall require to successfully undergo walking test of 25 kilometers in four hours in case of a male candidate and 14 kilometers in four hours in case of female candidate: Provided that in case a candidate, who has been called for appearing in the walking test; either fails to complete the walking test within the prescribed time limit or fails to appear in the test, shall be given another opportunity to appear in the walking test. In case if he again fails to appear or pass the walking test, no further opportunity shall be given to him to appear in the walking test.
(f)	The candidate selected shall have to pass medical examination as per Gujarat government rules.
(g)	Possess the basic knowledge of computer application as prescribed in Gujarat Civil services Classification and Recruitment (General) Rules, 1967;
5	Possess adequate knowledge of Gujarati or Hindi or Both; and
6	The provisions of rule 9-A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct selection. The candidate selected through the direct selection mode shall be appointed on contractual basis in accordance with and on such terms and conditions as prescribed by the Gujarat of Government from time to time and shall be given at the end of contractual period the pay scale prescribed for the concerned post on his/her performance being found satisfactory during the stipulated period of five years service on contractual basis.
7	The candidate appointed by direct selection shall, during his probation period, require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency (Training and Examination) Rules, 2006.
8	The candidate appointed by direct selection will be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
9	Interpretation in case of doubt: If any question arises as to the interpretation of any of these regulations, the question shall be referred to the Secretary to the Government; finance Department for the decision and his decision in the matter shall be final.
