ઉપરોક્ત વિષય અંગેનાં આપનાં સંદર્ભ દર્શિત પત્ર અન્વયે જણાવવાનું કે નાણા વિભાગે નિગમની આસી.સુપરવાઈઝર/વન ઓષધી આસી.સુપરવાઈઝર " ની જગ્યાના ભરતી નિયમો નીચે મુજબ મંજૂર કરેલ છે:

In exercise of the powers conferred by Object Clause no. 42 of Memorandum of Association of Gujarat State Forest Development Corporation Ltd (GSFDC Ltd.), and in supersession of all the existing rules made in this behalf, the Board of Directors makes the following rules to provide for regulating recruitment to the post of **Assistant Supervisor/ Van Aushadhi Assistant Supervisor** in GSFDC LTD. {Read with the Gujarat Civil Services Classification and Recruitment (General) Rules 1967, as amended from time to time.}

1 These rules may be called the "Assistant Supervisor/ Van Aushadhi Assistant Supervisor " in Gujarat State Forest Development Corporation Ltd, Recruitment Regulation, 2023.

2 Appointment to the post of Assistant Supervisor/ Van Aushadhi Assistant Supervisor in Gujarat State Forest Development Corporation Ltd, shall be made either:-

(a) **By direct selection/ on the basis of the result of the competitive examination held for the purpose;**

OR

(b) **By temporary transfer on deputation basis from amongst the persons working on the cadre of Guard from the Forest Department or from equivalent cadre of any other department of the Government of Gujarat.**

AND

He/She has passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency (Training and Examination) Rules, 2006;

3 To be eligible for appointment by direct selection to the post mentioned in

(a) Regulation -2 (a), candidate shall-
Not be more than 33 years of age;

Provided that age limit of candidates belonging to the Scheduled Caste, Scheduled Tribes and Socially and Educationally Backward Class and candidates who are women, will be relaxed to the extent of five years.

Services Classification and Recruitment (General) Rules 1967.
 Provided further that nothing contained sub-rule (9) of rule 8

Provided that no physically handicapped candidate shall be eligible to be appointed to the service. The following constitutes physical defects:

1. Knock - Knee
2. Bow Legs
3. Flat Feet
4. Varicose Veins
5. Hydrocele in men
6. Vision / Color blindness / night blindness
7. Impediment in speech and hearing

- (iii) Explanatory note for vision :

Distant Vision
 Better eye or Worse eye
 6/6 mtrs. 6/9 mtrs.

Near Vision
 Better eye or Worse eye
 0/6 mtrs. 0/8 mtrs.

Each eye must have full field vision. Colour blindness, squint or any morbid condition of the eyes or lids of either eye shall be deemed to be a disqualification.



(c) Test for vertigo

- Candidates with any defects observed during the tests (mentioned above) shall be disqualified.
- (v) Eligible candidates shall have to qualify a prescribed competitive entrance examination with minimum prescribed percentage of marks.
- (vi) Qualified candidates shall be called in the order of their merit, to qualify in a prescribed Physical endurance test.
- (vii) The candidate qualified in the prescribed exam mentioned in(i) & Physical endurance test mentioned above shall be required to pass the walking test of 25 Kms. in 4 hours for men and 16 Kms. in 4 hours for women.
- (viii) The candidate selected shall have to pass medical examination as per Gujarat government rules.
- (c) Possess adequate knowledge of Gujarati Hindi, or Both: and

The provisions of rule 9-A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct" selection.

The candidate selected through the direct selection mode shall be appointed on contractual basis in accordance with and on such terms and conditions as prescribed by the Gujarat Government from time to time and shall be given at the end of contractual period the pay scale prescribed for the concerned post on his/her performance being found satisfactory during the stipulated period of five years service on contractual basis or for the period as may be prescribed by the Gujarat Government from to time.

The candidate appointed by direct selection will be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.

Interpretation in case of doubt:

If any question arises as to the interpretation of any of these regulations, the question shall be referred to the Secretary to the Government, Finance Department for the decision and his decision in the matter shall be final.
